Dear Green New Deal Leader,

Are you wondering how the new climate initiative included in the Inflation Reduction Act (IRA), will impact you, our communities, and our climate?

**What's good about the new climate bill?**

The package will invest \$375 billion over the next decade in climate protection strategies including tax rebates for people to buy electric vehicles and 10 year consumer tax credits for renewable energy. For businesses, there are tax credits for solar and wind production. The bill pays for this and reduces the deficit with a 15% minimum corporate tax and restores IRS capacity to raise funds by going after tax cheats. The bill also extends some health insurance subsidies and allows Medicare to negotiate some prescription drug prices. For more detail at our website, click [here](#).

**What's not to like?**

Unfortunately, the new law subsidizes new nuclear power and carbon capture technologies. It also requires expansion of federal leasing for petroleum development, including a provision requiring oil lease auctions before the government can auction leases for solar and wind farms. (Source: [Grist](#), August 9, 2022) The package omits essential elements of the transition to a low-carbon economy, which would include development of green jobs in the care economy, and prioritizing safe, healthy families and communities by funding child care credit, free preschool and community college, and family leave. **What can we do now? Write or call our President, Senators and Congress members!**

First, we need to continue demanding that President Biden declare a climate emergency and take all possible pro-climate executive actions. Also, please keep urging our Senators and House members to continue seeking ways to protect our communities and climate starting with rejecting Manchin's "Side Deal" to fast track new fossil fuel pipelines.

In exchange for Manchin's vote for the bill, some U.S. Senate leaders promised Joe Manchin that they would support a separate bill for the fossil fuel industry: fast-tracking approvals for projects like the Mountain Valley Pipeline. This "pipeline deal" is separate from the IRA, so we still have a chance to stop it. Hundreds of organizations across the country are fighting to stop this, but we'll only win if they are joined by thousands of people.
